Appointment of Members of the Men's Senior Selection Committee and Men's Junior Selection Committee

The Uttar Pradesh Cricket Association (UPCA) invites Expressions of Interest from eligible former cricketers for appointment as members of the following committees:

1. **Men's Senior Selection Committee**
2. **Men's Junior Selection Committee**

Each Selection Committee shall consist of **five members as per vacancies**.

1. Men's Senior Selection Committee

The members of the Men's Senior Selection Committee shall be appointed by the **Cricket Advisory Committee**, comprising reputed former First-Class cricketers identified by UPCA at its Annual General Meeting, in accordance with the Constitution of UPCA.

Eligibility Criteria:

- Be a former cricket player;
- Have played at least **one First-Class cricket match conducted by the BCCI**; and
- Have retired from the game of cricket at least **five years prior to the date of appointment**.

2. Men's Junior Selection Committee

The members of the Men's Junior Selection Committee shall be appointed by the **Cricket Advisory Committee**, comprising reputed former First-Class cricketers identified by UPCA at its Annual General Meeting, in accordance with the Constitution of UPCA.

Eligibility Criteria:

- Be a former cricket player;
- Have played at least **one First-Class cricket match organised by the BCCI**; and
- Have retired from the game of cricket at least **five years prior to the date of appointment**.

Application Requirements

Interested candidates must clearly specify the committee for which they are applying. Candidates wishing to be considered for both committees may indicate both preferences in the same application.

The application should be accompanied by:

- A detailed résumé/profile outlining the applicant's cricketing experience;
- Details and supporting records of First-Class matches played;
- Documentary proof or a self-declaration regarding retirement from cricket;
- A self-declaration confirming fulfilment of the prescribed eligibility criteria;
- Details of any current position or association with a cricket organisation, academy, club or team; and
- Complete contact details, including postal address, mobile number and email address.
