General Eligibility and Experience

- Applicants must possess sound technical knowledge, leadership ability, communication skills, and the capacity to work effectively in a professional team environment.
- Candidates must be physically fit and willing to travel and remain with the team during camps, tournaments, and other assignments.
- All appointments shall be subject to the applicable provisions of the Constitution, Rules, Regulations, policies, and Conflict of Interest norms of UPCA and the BCCI.
